FIRST ANNOUNCEMENT - CALL FOR PAPERS

At the European Conference in Parma in March 2007 colleagues engaged in social work education and social services participated in a roundtable session with professor Joe Wronka, Springfield College/Massachusetts, expert in human rights and extreme poverty at the United Nations, Geneva Office. This session closed with the idea of creating a European network dedicated to facilitate interaction and constructive discourses in the promotion of teaching and training about human rights in all areas of social work.

This network developed and expanded - enabling us to share our understanding, concepts and experiences of social work and human rights at a pre-conference that took place prior to the European Social Work Conference (ENSACT) in Dubrovnik, Croatia in April 2009. Over 40 colleagues and students from universities and social services, throughout Europe and abroad, participated in it. Possible topics at the 2nd pre-conference could be for example:

- What are basic philosophical, religious, ethical foundations of human dignity and human rights?
- Contradictions between human rights in social work practice which way out?
- Poverty as violation of social rights
- Social justice, human rights and social work practice
- Culture, religion and human rights
- Best practice examples and experiences how to teach human rights

We are open for further suggestions focusing on human rights.

We would then like to discuss if there is interest in working on a project to establish an International Master of "Social Work and Human Rights" between European universities/ Universities of Applied Sciences.
